

CALL FOR EXPRESSIONS OF INTEREST: RECOMMENDATION PANEL FOR THE 7TH TERM COUNCIL NOMINATION PROCESS - PROJECT AND CONSTRUCTION MANAGEMENT EDUCATION REPRESENTATIVE.

The South African Council for the Project and Construction Management Professions (SACPCMP) is a statutory body established in terms of section 2 of the Project and Construction Management Professions Act, 2000 (Act No. 48 of 2000). The SACPCMP is responsible for the regulation of the Project and Construction Management Professions and for maintaining standards of professional competence, conduct, and ethics within the professions.

In support of the 7th Term Council Nomination Process, the Council hereby invites suitably qualified registered persons for appointment to the Council Nomination Recommendation Panel in terms of Rule 8.2(b) of the Rules and Procedures for the Nomination of Council Members. Rule 8.2(b) requires the inclusion on the Recommendation Panel of one registered person with special knowledge of project and construction management education. The Recommendation Panel will assist the Council in evaluating and assessing nominations received for election to the 7th Term Council.

ROLE OF THE PANEL

The Council Nomination Recommendation Panel will, amongst others:

- Evaluate all nominations received and assess compliance with the requirements of the Project and Construction Management Professions Act, 2000 (Act No. 48 of 2000), the applicable Rules, and Council governance requirements.
- Assess the qualifications, experience, competencies, and suitability of nominated candidates for appointment to Council.
- Ensure that appropriate consideration is given to transformation, geographic representivity, diversity, consistency, continuity, and uniformity in the nomination and recommendation process.

- Verify the eligibility of nominees and identify candidates who satisfy the requirements prescribed by legislation and Council Rules.
- Compile and submit a report to Council containing a list of all nominations received, recommended nominees, a reserve list of nominees, and nominees who do not meet the requirements, together with reasons for such findings.
- Provide independent recommendations to Council regarding the suitability and eligibility of nominees for consideration by the Minister.
- Ensure that the nomination process is conducted fairly, transparently, objectively, and in accordance with the principles of good governance.
- Maintain confidentiality throughout the nomination process and declare any actual, potential, or perceived conflicts of interest.

REQUIREMENTS FOR ELIGIBILITY

Applicants must:

- a. Be a registered person with SACPCMP and be in good standing.
 - Demonstrate special knowledge and experience in project and construction management education.
- b. Hold a recognised tertiary qualification with a minimum NQF Level 7 in:
 - Construction Management; or
 - Construction Health and Safety Management.
- c. Possess a minimum of five (5) years' relevant post-registration experience within the construction industry and the profession concerned after obtaining professional registration with the Council.
- d. Not be subject to any disciplinary sanction or suspension by the SACPCMP at the time of application.

GENERAL INFORMATION AND INSTRUCTIONS

- Applicants must submit:
 - A detailed Curriculum Vitae (CV);
 - Certified copies of qualifications (not older than three months);

- Certified copy of Identity Document (not older than three months);
 - Proof of current SACPCMP registration and good standing.
- Appointment to the Recommendation Panel will be for purposes of assisting the SACPCMP with the 7th Term Council nomination and election process.
