## INVITATION FOR APPLICATIONS AS CO-OPTED/INDEPENDENT MEMBERS TO VARIOUS COMMITTEES OF THE SOUTH AFRICAN COUNCIL FOR THE PROJECT AND CONSTRUCTION MANAGEMENT PROFESSION (“SACPCMP”)

### 1. INTRODUCTION

The SACPCMP invites applicants from qualifying and interested candidates to be appointed as co-opted members of the following committees of the Council of the SACPCMP:

- Audit and Risk Committee
- Human Resources, Remuneration and Nominations Committee
- Social and Ethics Committee
- Investigation Committee

The successful candidates will, by means of this process, fill the above positions for the same term as that of the currently appointed Council members, and shall be subject to review as and when deemed fit by the Council.

### 2. BACKGROUND ABOUT THE SACPCMP

The SACPCMP was established to regulate and promote specific Built Environment Management Professions and is a juristic person established by the Project and Construction Management Professions Act (Act No.48 of 2000) to provide for the registration of professionals, candidates and specified categories in the project and construction management professions; to provide for the regulation of the relationship between the SACPCMP and the Council for the Built Environment; and to provide for matters connected therewith.

### 3. MINIMUM ELIGIBILITY SELECTION CRITERIA

Human Resources, Remuneration and Nominations Committee	minimum NQF level 7 qualification in industrial psychology/Human resource management	minimum of 5 years Professional experience at Management level.

		May possess, as an advantage, the requisite Professional Registration where applicable.
Social and Ethics Committee	minimum NQF level 7 qualification in governance/ social sciences/ labour law/ stakeholder management	minimum of 5 years Professional experience at Management level.
Investigation Committee	minimum NQF level 7 qualification in corporate investigative auditing /Fraud and investigation, LLB	Must at least have appropriate three to five years' experience in conducting investigations and generating the investigation report.  Knowledge and experience of the Built Environment, or professional registration in the built environment will be an added advantage.

### 3.2 Disqualifying criteria:

- If candidates hold a Governance and/or Management position in either Recognised or non-recognised Voluntary Association(s) operating within the Council's registrable categories;
- Has an active Economic and/or Governance and/or Management interest in any of Councils' service providers (conflict of interest);
- Has active Governance and/or Management and/or Employee interest in any Institution/Organisation that is subject to Council's Regulatory functions jurisdiction.

- Willingness to dedicate time and effort
- Good communication skills
- Sound analytical skills
- Decisiveness
- Strong leadership skills with ability to interact at Council and Executive level

All applications received shall be subjected to, *inter alia*, background and reference checks on prospective candidates.
